

STATEMENT OF PURPOSE
OF
HUERFANO COUNTY HOSPITAL DISTRICT

TO: Board of County Commissioners of Huerfano County
City of Walsenburg
Division of Local Government

Pursuant to the provisions of Section 32-1-208, C.R.S., as amended, Huerfano County Hospital District, a hospital district located in Huerfano County, Colorado, hereby files the following statement of purposes:

1. Purpose for which organized. The District was organized as a hospital district by Court Decree May 19, 1961, for the following purposes: to operate a public hospital and other facilities providing health and personal care services.

2. Services and Facilities. The District provides, or may provide in the future, the following services: public hospitals, convalescent centers, nursing care facilities, intermediate care facilities, emergency facilities, community clinics, and other facilities providing health and personal care services and may organize, own, operate, control, direct, manage, contract for, or furnish ambulance service. In addition thereto, the District may provide any other services so authorized by law.

In conjunction therewith, the District operates, or may operate in the future, all facilities related to the provision of services specified herein, including: hospitals, convalescent centers, emergency medical facilities, clinics, and ambulances.

3. Service Area. The District serves, or may serve in the future, all areas within the current jurisdictional boundaries of the District, as well as areas which may be subsequently included therein as determined by the Board of Directors, in its discretion, in accordance with the provisions of Part 4, Title 32, C.R.S., as amended. A current map of District boundaries is attached hereto.

Also enclosed herewith is the current list of District information required pursuant to Section 32-1-104, C.R.S., as amended.
